RESOLUTION NO. 105

“Presented for consideration Resolution No. 2, current series, of the City Development Council, this city, requesting the Sangguniang Panlungsod to re-appropriate the amount of One Million One Hundred Thousand Pesos (PHP1,100,000.00) intended for pre/post harvest facilities to the unappropriated balance of the Economic Development Fund and to appropriate the same as Subsidy to Cooperatives for Cotton Post Harvest Facilities and to include the same in the Annual Investment Plan (AIP) of the City for CY 2005 which was inadvertently omitted.

“RESOLVED, To approve the foregoing resolution.

“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 3

AN ORDINANCE REVERTING THE AMOUNT OF PHP1,100,000.00 REPRESENTING THE CONTINUING APPROPRIATION FOR PRE/POST HARVEST FACILITIES FOR COTTON PRODUCTION UNDER THE 38% EDF FOR CY2004 TO THE UN-APPROPRIATED BALANCE OF THE ECONOMIC DEVELOPMENT FUND FOR CY 2004 AND TO RE- APPROPRIATE THE SAME AS SUBSIDY TO COOPERATIVES FOR COTTON POST HARVEST FACILITIES AND TO INCLUDE THE SAME IN THE ANNUAL INVESTMENT PLAN OF THE CITY FOR CY 2005.

Be it ordained that:

SECTION 1. The amount Php1,100,000.00 representing the continuing

appropriation for pre/post harvest facilities for cotton production under 38% EDF for CY 2004 is hereby reverted to the un-appropriated balance of the Economic Development Fund for CY2004 and to re-appropriate the same as subsidy to cooperatives for cotton pre/post harvest facilities and to include the same in the annual investment plan of the city for CY 2005.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the Local Government Code of 1991.
