“Presented for consideration Resolution No. 1, current series, of the City Development Council, this city, requesting the City Council to revert the amount of PHP300,000.00 representing the LGU-Equity of the city for the construction of ERAP Food Security Warehouse in Barangay Kalumboyan to the Unappropriated balance of the Economic Development Fund and to re-appropriate the same for the construction of a Multi-purpose Drying Pavement in Sitio, Tiki, Barangay Kalumboyan, this city.

“RESOLVED, to approve the foregoing resolution.

“RESOLVED FURTHER, to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 18

AN ORDINANCE REVERTING THE AMOUNT OF PHP300,000.00 REPRESENTING THE LGU-EQUITY OF THE CITY FOR THE CONSTRUCTION OF ERAP FOOD SECURITY WAREHOUSE IN BARANGAY KALUMBOYAN TO THE UNAPPROPRIATED BALANCE OF THE ECONOMIC DEVELOPMENT FUND AND TO RE-APPROPRIATE THE SAME FOR THE CONSTRUCTION OF A MULTI-PURPOSE DRYING PAVEMENT IN SITIO, TIKI, BARANGAY KALUMBOYAN, THIS CITY.

Be it ordained that:

SECTION 1. The amount of PHP300,000.00 representing the LGU-Equity of the city for the construction of ERAP Food Security Warehouse in Barangay Kalumboyan is hereby reverted to the Unappropriated balance of the Economic Development Fund and re-appropriate the same for the

construction of a Multi-purpose Drying Pavement in Sitio, Tiki, Barangay Kalumbuyan, this city.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A.7160, the LGC of 1991.
