
“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance:

APPROPRIATION ORDINANCE NO. 10

Be it ordained that:

Section 1. The amount of PHP1,000,000.00 out of the PHP3,000,000.00 appropriation under the CY 2016 20% Economic Development Fund for the Installation of Guardrails at Kalumboyan Bridge Approaches is hereby appropriated for the Construction of the Water System for the United Farmers Association of Tayawan in the amount of P300,000.00, Installation of Street Lightings at Barangay Proper Villasol in the amount of P140,000.00, Improvement of Road along Bayawan CIP Main Canal in the amount of P190,000.00, Construction of Footbridge at Sitio Lower Baican, Barangay Villasol in the amount of P220,000.00 and Construction of Rain Collector at Barangay San Isidro in the amount of P150,000.00.

Section 2. This ordinance shall take effect upon the approval of the Local Chief Executive.
