**RESOLUTION NO. 572**

RESOLUTION ENACTING ORDINANCE NO. 42, AN ORDINANCE MANDATING THE TRANSFER OF PLANTILLA POSITIONS FROM THE CITY MAYOR'S OFFICE TO THE OFFICE OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRMO) OF THE CITY GOVERNMENT OF BAYAWAN

“WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers local government units to exercise powers necessary and appropriate for the promotion of the general welfare;

“WHEREAS, pursuant to Section 458 of the same Code, the Sangguniang Panlungsod is mandated to enact ordinances and approve measures that will enhance the delivery of basic services, including disaster preparedness, risk reduction, and emergency response;

“WHEREAS, on July 22, 2024, the Office of the Local Disaster Risk Reduction and Management (LDRRMO) of the City Government of Bayawan was officially created under Ordinance No. 16, series of 2014, which includes its plantilla positions to support its organizational functions;

“WHEREAS, several plantilla positions originally drawn from the City Mayor's Office remain formally under its previous mother office despite performing functions under the Office of the Local Disaster Risk Reduction and Management (LDRRMO);

“WHEREAS, transferring these plantilla positions to their rightful office will strengthen the organizational structure, streamline operations, and enhance the efficiency and effectiveness of disaster risk reduction and management programs in the city;

“WHEREFORE, on motion of Honorable Councilor Renacia and jointly seconded by Honorable Councilor Sumalpong and Honorable Councilor Abrasaldo, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

Ordinance No. 42

AN ORDINANCE MANDATING THE TRANSFER OF PLANTILLA POSITIONS FROM THE CITY MAYOR'S OFFICE TO THE OFFICE OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRMO) OF THE CITY GOVERNMENT OF BAYAWAN

Be it ordained that:

Section 1. Transfer of Plantilla Positions. The following positions under the Plantilla of the City Mayor's Office are hereby transferred to the Office of the Local Disaster Risk Reduction and Management (LDRRMO), to wit:

1. Local Disaster Risk Reduction and Management Officer IV – Item No. DRRM-1
2. Local Disaster Risk Reduction and Management Officer II – Item No. DRRM-2.1
3. Local Disaster Risk Reduction and Management Officer II – Item No. DRRM-2.2
4. Local Disaster Risk Reduction and Management Officer II – Item No. DRRM-2.3

Section 2. RULE ON NON-DIMINUTION. The transfer shall not diminish the compensation and/or salary for the said positions.

Section 3. PERSONNEL SERVICES (PS) requirements for the subject transferred positions shall already be included in the total PS appropriations of the LGU Bayawan City that will be subject to the PS limitation pursuant to section 325 (a) of the Local Government Unit Code; and the PS requirements for the subject transferred positions shall be given priority in the PS appropriations under the General Fund over non-mandatory PS items of appropriations.

Section 4. This ordinance shall take effect after the compliance with the provisions of R.A. 7160, the Local Government Code of 1991
