“WHEREAS, the Tayawan Rural Improvement Club, through its President, Rosemarie L. Almaden, has signified its intention to be an accredited CSO in the Local Government Unit of Bayawan City to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

“WHEREAS, the Tayawan Rural Improvement Club has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2022-083.

“WHEREFORE, on motion of Honorable Councilor Casipong and duly seconded Honorable Councilor Sumalpong, the Council

“RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod to approve and grant the accreditation of Tayawan Rural Improvement Club in the Local Government Unit of Bayawan City.

“RESOLVED FURTHER, that this accreditation is effective only until June 30, 2025


