ORDINANCE NO. 35

AN ORDINANCE RENAMING/CHANGING THE NAME OF DAWIS NATIONAL HIGH SCHOOL TO NICOLAS A. CATAYLO HIGH SCHOOL

Be it ordained that:

SECTION 1. Dawis National High School located at Dawis, Bayawan City is hereby renamed to NICOLAS A. CATAYLO HIGH SCHOOL (Formerly DAWIS NATIONAL HIGH SCHOOL).


SECTION 2. This ordinance shall take effect upon the compliance of the provisions of Republic Act No. 7190, the Local Government Code of 1991.


