“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 1

AN ORDINANCE REVERTING THE AMOUNT OF 46,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR THE CONSTRUCTION OF THE IT EXTENSION OF THE OFFICE OF THE CITY MAYOR TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR VARIOUS EXPENDITURES OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP46,000.00 representing savings in continuing appropriation for the Construction of the IT Extension of the Office of the City Mayor is hereby reverted to the Un-appropriated Balance of the General Fund and re-appropriate the same of the said office for the following:

Capital Outlay	
IT Equipment and Software	PHP36,000.00
Other Property, Plant & Equipment	10,000.00

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160.


