“RESOLVED, to approve the foregoing request of the Honorable Mayor and to enact, as it hereby enacts the following ordinance to wit:

ORDINANCE NO. 16

AN ORDINANCE REVERTING THE AMOUNT OF PHP13,950.62 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR OFFICE IMPROVEMENT (EXTENSION OF OFFICE SPACE) OF THE ACCOUNTING OFFICE TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR FURNITURE AND FIXTURES OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount PHP13,950.62 representing savings in continuing appropriation for Office Improvement (Extension of Office Space) of the Accounting Office is hereby reverted to the unappropriated balance of the General Fund and re-appropriate the same for Furniture and Fixtures of the said office.

SECTION 2. This ordinance shall take effect after compliance with the provision of R.A 7160, the Local Government Code of 1991.
