“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 21

AN ORDINANCE REVERTING THE AMOUNT OF P16,350.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR COMMUNICATION EQUIPMENT OF THE OFFICE OF THE CITY ENVIRONMENT AND NATURAL RESOURCES TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR IT EQUIPMENT AND SOFTWARE OF THE SAID OFFICE.

Be it ordained that:

SECTION. 1. The amount of P16,350.00 representing savings in continuing appropriation for Communication Equipment of the Office of the City Environment and Natural Resources is hereby reverted to the un-appropriated balance of the General Fund and re-appropriate the same for IT Equipment and Software of the said office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.




