“RESOLVED, to approve the foregoing request of the Honorable Mayor German P. Saraña Jr. and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 38

AN ORDINANCE REVERTING THE AMOUNT OF PHP300,000.00 REPRESENTING THE OBLIGATED APPROPRIATION FOR LGU COUNTERPART FOR CONSTRUCTION OF A SCHOOL BUILDING – BRGY. MINABA TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR THE CONSTRUCTION OF 1 UNIT SCHOOL BUILDING, PHASE I-BARANGAY MINABA.

Be it ordained that:

SECTION 1. The amount of Php300,000.00 representing the obligated appropriation for LGU Counterpart for construction of a school building – Brgy. Minaba is hereby reverted to the un-appropriated balance of the General Fund and re-appropriate the same for the construction of 1 unit school building, Phase I-Barangay Minaba.

SECTION 2. This ordinance shall take effect after compliance with the provisions of RA7160.
