AN ORDINANCE REVERTING THE AMOUNT OF P 56,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR FURNITURE AND FIXTURES OF THE CITY CIVIL REGISTRY TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR VARIOUS EXPENDITURES OF THE SAID OFFICE.

SECTION 1.
