AN ORDINANCE REVERTING THE AMOUNT OF PHP56,434.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR FIREFIGHTING EQUIPMENT AND ACCESSORIES OF THE GENERAL SERVICES OFFICE TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR VARIOUS CAPITAL OUTLAY EXPENDITURES OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP56,434.00 representing savings in continuing appropriation for Firefighting Equipment and Accessories of the General Services Office is hereby reverted to the un-appropriated balance of the General Fund and re-appropriate the same for the following, to wit:
