“Letter dated May 6, 2005 of the Honorable City Mayor G. Sarafia Jr. requesting for the reversion of PHP10,000,000.00 representing the obligated amount for subsidy to Socialized Housing Project to the un-appropriated balance of the General Fund and to re-appropriate the same for the construction of a Waste Water Treatment Facilities considering the dire need to construct first the Waster Water Treatment Facilities before the full implementation of the Socialized Housing Project.

“RESOLVED, to approve the foregoing request of the Honorable City Mayor.

“RESOLVED FURTHER, to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 16

AN ORDINANCE REVERTING OF PHP10,000,000.00 REPRESENTING OBLIGATED AMOUNT FOR SUBSIDY TO SOCIALIZED HOUSING PROJECT TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR THE CONSTRUCTION OF A WASTE WATER TREATMENT FACILITIES.

Be it ordained that:

SECTION 1. The amount of PHP10,000,000.00 representing obligated amount for subsidy to socialized housing project is hereby reverted to the un-appropriated balance of the general fund and re-appropriate the same for the construction of a waste water treatment facilities.


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the Local Government Code of 1991.
