ORDINANCE NO. 10

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP31,010,309.51 REPRESENTING THE RETAINED EARNINGS UN-APPROPRIATED/TOTAL UN-OBLIGATED ALLOTMENT UNDER THE MOOE OF THE 50% LOCAL DEVELOPMENT FUND TO FUND VARIOUS PROGRAMS AND PROJECTS OF THE CITY GOVERNMENT

Be it ordained that:

SECTION 1. The amount of PHP31,010,309.51 representing the retained earnings un-appropriated/total un-obligated allotment under the MOOE of the 50% Local Development Fund is hereby appropriated to fund various programs and projects of the City Government, to wit:




