"RESOLVED, To enact, as it hereby enacts the following ordinance to wit:

ORDINANCE NO. 5

AN ORDINANCE REVERTING THE AMOUNT OF PHP100,000.00 UNDER THE APPROPRIATION OF THE SLAUGHTERHOUSE FOR OTHER SERVICES OF THE GENERAL FUND BUDGET FOR CY 2002 TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME THE PURCHASE OF ONE UNIT MOTORCYCLE FOR THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP 100,000.00 representing the appropriation of the Slaughterhouse for Other Services of the General Fund Budget for CY 2002 is hereby reverted to the Unappropriated Balance of the General Fund and re-appropriate the same for the purchase of one unit motorcycle for the said office.

"SECTION 2. This ordinance shall take effect after compliance with the provisions of R.A. 7160.
