RESOLUTION NO. 208

"Letter dated April 12, 2002 of the Hon. Mayor German P. Saraña Jr. requesting for a supplemental appropriation of the PHP6 Million savings of the PHP35 Million Acquisition Budget for CY 2001 and the PHP11 Million Loan Balance from Land Bank of the Philippines for the acquisition of various heavy equipment for the City Government.

"RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 8

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP11,000,000.00 OUT OF THE UNRELEASED PORTION OF THE APPROVED LOAN FROM LAND BANK OF THE PHILIPPINES FOR THE ACQUISITION OF VARIOUS HEAVY EQUIPMENT FOR THE USE OF THE CITY GOVERNMENT.

Be it ordained that:

SECTION 1. The amount of PHP11,000,000.00 out of the unreleased portion of the approved loan from Land Bank of the Philippines is hereby appropriated for the acquisition of the following heavy equipment, to wit:

4 Units	Reconditioned 10-Wheeler Dump Trucks, Powered by 340 HP Diesel Engine, Left Hand Drive, Double Differential, Brand New Tires and Batteries, Brand New Air and Engine Oil Filters and New Engine Oil	PHP4,000,000.00
1 Unit	Reconditioned Bulldozer, Power Shift, Powered by 320 HP Diesel Engine, with Brand New Track Pads, Links, Pins and Bushings, Brand New Lower and Upper Rollers, Brand New End Bits and Cutting Edge, Brand New Air and Engine Filters, Hydraulic Filters and New Engine and Hydraulic Oils	PHP7,000,000.00
