“RESOLVED, to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 22

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP560,000.00 OUT OF THE UNAPPROPRIATED SURPLUS OF THE GENERAL FUND (EMINENT DOMAIN ACCOUNT WITH THE DEVELOPMENT OF THE PHILIPPINES) TO COVER THE VARIOUS EXPENSES OF THE CITY GOVERNMENT.

Be it ordained that:

SECTION 1. The amount of PHP560,000.00 is hereby appropriated out of the Unappropriated Surplus of the General Fund (Eminent Domain Account with the Development Bank of the Philippines) to cover the various expenses of the city government.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R.A. 7160.
