ORDINANCE NO. 7

AN ORDINANCE APPROPRIATING THE AMOUNT OF  
PHP150,000,000.00 OUT OF THE APPROVED LOAN FROM LAND BANK  
OF THE PHILIPPINES FOR THE CONSTRUCTION OF BAYAWAN  
WAVES ADVENTURE PARK UNDER THE CITY ENGINEERING OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP150,000,000.00 is hereby appropriated out of the approved loan from Land Bank of the Philippines for the construction of Bayawan Waves Adventure Park under the City Engineering Office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


