ORDINANCE NO. 28

AN ORDINANCE REVERTING THE AMOUNT OF PHP26,879.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR LIBRARY BOOKS OF THE OFFICE OF THE CITY LEGAL OFFICER TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND RE-APPROPRIATE THE SAME FOR IT EQUIPMENT AND SOFTWARE FOR THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP26,879.00 representing savings in continuing appropriation for Library Books of the Office of the City Legal Officer is hereby reverted to the un-appropriated balance of the general fund and re-appropriate the same for IT Equipment and Software for the said office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160.
