The amount of PHP2,507,856.32 representing savings in continuing appropriations is hereby reverted to the un-appropriated balance of the General Fund – Proper, Economic Development Fund, and Economic Enterprise respectively and be made available to fund other priority projects of the city.


SECTION 2. This ordinance shall take effect after compliance with provisions of R.A. 7160, the LGC of 1991.


