"RESOLVED, to approve the foregoing request and to enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 43

AN ORDINANCE REVERTING THE AMOUNT OF PHP14,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATIONS FOR TECHNICAL AND SCIENTIFIC EQUIPMENT OF THE IT SECTION TO THE UN - APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE PURCHASE OF 1 UNIT LCD MONITOR FOR THE SAID OFFICE.

Be it ordained that:

SECTION 1. The total amount of 14,000.00 representing savings in continuing appropriations for technical and scientific equipment of the IT Section is hereby reverted to the un - appropriated balance of the general fund and to re-appropriate the same for the purchase of 1 unit LCD monitor for the said office.

SECTION 2. This ordinance shall take effect after compliance with the Local Government Code.


