“RESOLVED, To approve the foregoing request and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 14

AN ORDINANCE REVERTING THE AMOUNT OF PHP12,300.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR MOTOR VEHICLES OF THE PUBLIC MARKET OPERATION TO THE UN-APPROPRIATED BALANCE OF ECONOMIC ENTERPRISES FUND AND TO RE-APPROPRIATE THE SAME FOR COMMUNICATION EQUIPMENT.

Be it ordained that:

SECTION 1. The amount of PHP12, 300.00 representing savings in continuing appropriation for Motor Vehicles of the Public Market Operation is hereby reverted to the un-appropriated balance of the Economic Enterprises Fund and to re-appropriate the same for communication equipment.


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.




