- c. That the program can be availed by qualified employees and officials without disruption of their duties and responsibilities and allowing them to participate in a premier program with minimum financial burden as the program is conducted here in locality.
- d. That the budget for the proposed MPM program can be supported by the budget of the City Government.

ORDINANCE NO. 37

AN ORDINANCE APPROPRIATING THE TOTAL AMOUNT OF PHP1,682,565.58 REPRESENTING THE UN-APPROPRIATED SURPLUS CY 2008 OPERATION IN THE AMOUNT OF PHP1,000,000.00 OF THE GENERAL FUND AND INTEREST EARNED FROM VARIOUS BANK DEPOSITS IN THE AMOUNT OF PHP682,565.58 FOR THE MASTER IN PUBLIC MANAGEMENT (MPM) PROGRAM OF THE LOCAL GOVERNMENT UNIT.

Be it ordained that:

SECTION 1. The total amount of PHP1,682,565.58 representing the Un-appropriated Surplus CY

2008 operation in the amount of PHP1,000,000.00 of the General Fund and Interest Earned from Various Bank Deposits in the amount of PHP682,565.58 is hereby appropriated for the Master in Public Management (MPM) Program of the Local Government Unit.


SECTION 2. This ordinance shall take effect after compliance with the provisions of RA7160.


