“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 20

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP100,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR OFFICE SUPPLIES EXPENSES OF THE CITY ADMINISTRATOR UNDER THE GENERAL FUND FOR THE ACQUISITION OF OFFICE EQUIPMENT – I D MAKER OF THE SAID OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP100,000.00 representing savings in current appropriation for Office Supplies Expenses of the Office of the City Administrator under the general fund is hereby re-appropriated for the acquisition of office-equipment – ID Maker.

SECTION 2, This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


