Saraña, Jr., requesting for the reversion of the amount PHP400,000.00 representing continuing appropriation for Comfort Room Construction – Coastal Road same being not feasible for implementation to the un-appropriated balance of the general fund and to re-appropriate the same for the Purchase of Portable Toilets for installation along the Coastal Road.

“On motion of Honorable Councilor Albito and duly seconded by Honorable Councilor Sumalpong, the Council

“RESOLVED, To approve the foregoing request of the Honorable Mayor and to enact as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 7

AN ORDINANCE REVERTING THE AMOUNT PHP400,000.00 REPRESENTING THE CONTINUING APPROPRIATION FOR COMFORT ROOM CONSTRUCTION – COASTAL ROAD OF THE CITY ENGINEERING OFFICE SAME BEING NOT FEASIBLE FOR IMPLEMENTATION TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE PURCHASE OF PORTABLE TOILETS FOR INSTALLATION ALONG THE COASTAL ROAD.

Be it ordained that:

SECTION 1. The amount of PHP400,000.00 representing the continuing appropriation for Comfort Room Construction – Coastal Road of the City Engineering Office same being not feasible for implementation is hereby reverted to the un-appropriated balance of the general fund and to re-appropriate the same for the Purchase of Portable Toilets for installation along the Coastal Road.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160.


