ORDINANCE NO. 13

AN ORDINANCE REVERTING THE AMOUNTS OF P1,457,621.76 AND P1,771,514.30 REPRESENTING SAVINGS OF COMPLETED PROJECTS AS CERTIFIED BY THE CITY ENGINEERING OFFICE TO THE UN-APPROPRIATED BALANCES OF THE GENERAL FUND AND ECONOMIC DEVELOPMENT FUND RESPECTIVELY AND BE MADE AVAILABLE TO FUND OTHER PRIORITY PROJECTS OF THE CITY.

Be it ordained that:

SECTION 1. The amounts of P1,457,621.76 and P1,771,514.30 representing savings of completed projects as certified by the City Engineering Office are hereby reverted to the un-appropriated balances of the General Fund and Economic Development Fund respectively and to be made available to fund other priority projects of the city.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160.
