ORDINANCE NO. 16

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP126,000.00 OUT OF THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND FOR AID TO PNP UNDER THE SPECIAL PURPOSE APPROPRIATION OF THE CITY GOVERNMENT.

Be it ordained that:

SECTION 1. The amount of PHP126,000.00 out of the un-appropriated balance of the General Fund is hereby appropriated for Aid to PNP under the Special Purpose appropriation of the City Government.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.
