"WHEREFORE, on motion of Honorable Councilor Lamis and duly seconded by Honorable Trias, LNMB Vice President, the Council

"RESOLVED, To enact, as it hereby enacts, the following ordinance, to wit:

ORDINANCE NO. 25

AN ORDINANCE ABOLISHING THE POSITION OF ADMINISTRATIVE OFFICER V (RECORDS OFFICER I) WITH SALARY GRADE 10 UNDER THE OFFICE OF THE CITY PUBLIC SAFETY OFFICE AND TO CREATE THE POSITIONS OF TWO (2) UTILITY WORKERS UNDER THE SAME OFFICE.

Be it ordained that:

SECTION 1. The position of Administrative Officer V (Records Officer I)with Salary Grade 10 under the Office of the City Public Safety Office is hereby abolished and to create the positions of two (2) Utility Workers I in lieu of the abolished position also under the said office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R.A. 7160, the LGCC of 1991.


