“WHEREAS, said request was approved last September 28, 2012 except for the Special Purpose Appropriation – Assistance to Barangays-Medical/Mortuary/Fuel in the amount of PHP500,000.00 which was held in abeyance pending further study by the Committee on Health;

“WHEREAS, after consultation and verification with the City Social Welfare and Development Officer, it was found out that said allocation is very necessary and needed by the constituents of the city.

“WHEREFORE, on motion of Honorable Councilor Aurelia and duly seconded by Honorable Councilor Renacia, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 36

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP500,000.00 OUT OF THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND FOR ASSISTANCE TO BARANGAYS-MEDICAL/MORTUARY/FUEL.

Be it ordained that:

SECTION 1. The amount of PHP500,000.00 out of the un-appropriated balance of the General Fund is hereby appropriated for Assistance to Barangays-Medical/Mortuary/Fuel under the Special Purpose Appropriation.


Section 2. This ordinance shall take effect after the compliance with the provisions of R.A. 7160, the LGC of 1991.


