ORDINANCE NO. 40

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP200,000.00 OUT OF THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND FOR ENVIRONMENTAL SANITATION PROGRAM OF THE CITY HEALTH OFFICE.

Be it ordained that:

SECTION 1. The amount of PHP200,000.00 out of the unappropriated balance of the General Fund is hereby appropriated for Environmental Sanitation Program of the City Health Office.

SECTION 2. This ordinance shall take effect after the compliance with the provisions of R.A. 7160, the LGC of 1991.




