ORDINANCE NO. 41

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP24,622.34 OUT OF THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND 2012 FOR ELECTRICITY EXPENSES UNDER THE OFFICE OF THE MAYOR.

Be it ordained that:

SECTION 1. The amount of PHP24,622.34 out of the unappropriated balance of the General Fund 2012 is hereby appropriated for Electricity Expenses under the Office of the Mayor.

SECTION 2. This ordinance shall take effect after the compliance with the provisions of R.A. 7160, the LGC of 1991.
