Be it ordained that:


SECTION 1. The amount of PHP50,000.00 out of the un-appropriated portion of sales of assets under the General Fund is hereby appropriated for Health Workers Benefits-Medico Legal Allowance of the City Health Office.


SECTION 2. This ordinance shall take effect after the compliance with the provisions of R.A. 7160, the LGC of 1991.
