ORDINANCE NO. 59

AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP1,175,489.00 REPRESENTING THE 20% OF THE 6<sup>TH</sup> YEAR INSTALLMENT OF CY’S 2000 & 2001 UN-PROGRAMMED IRA AND 2<sup>ND</sup> YEAR INSTALLMENT OF IRA DIFFERENTIAL OF CY 2001 & 2004 TO FUND VARIOUS PROJECTS OF THE LOCAL GOVERNMENT UNIT.

Be it ordained that:




