“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 69 – B

AN ORDINANCE TEMPORARILY CLOSING VARIOUS CITY STREETS FROM VEHICULAR TRAFFIC AND PEDESTRIANS ON DECEMBER 23, 2018 FOR THE CHARTER DAY CELEBRATION

Be it ordained that:

Section 1. The following streets are hereby declared temporarily closed to Pedestrian and Vehicular Traffic respectively on December 23, 2018 for the Charter Day Celebration:

- Full road closure of Boulevard from corner Bollos Street to corner Zamora Street;
- Close to Pedestrian and Vehicular Traffic – entry of Zamora Street along corner Teologio Street; and
- Close to Vehicular Traffic – entry of Quindo Street along corner Teologio Street.

Section 2. This ordinance shall take effect upon the approval of the Local Chief Executive.




