“RESOLVED FURTHER, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 19

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP500,000.00 REPRESENTING THE SAVINGS FOR THE COMPLETION OF 2-CL BUILDING AT KALAMTUKAN ELEMENTARY SCHOOL UNDER THE CY2011 20% EDF FOR THE CONSTRUCTION OF THE STA. BAYABAS DISTRICT HEALTH OFFICE (PHASE 3).

Be it ordained that:

SECTION 1. The amount of PHP500,000.00 representing the savings for the completion of 2-CL Building at Kalamtukan Elementary School under the CY2011 20% EDF is hereby re-appropriated for the construction of the Sta. Bayabas District Health Office (Phase 3).

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


