"On motion Honorable Councilor Duque and duly seconded by Honorable Councilor Trias, the Council


"RESOLVED, To approve the request of the Honorable Mayor Ismael P. Martinez and to enact, as it hereby enacts the following ordinance:

APPROPRIATION ORDINANCE NO. 42

Be it ordained that:

SECTION 1. The amount of PHP2,763,257.36 representing savings in the continuing appropriation under the Economic Development Fund (EDF) for the construction of Kalumbuyan Bridge Phase 1 is hereby reverted to the unappropriated balance of the Economic Development Fund and to appropriate the same for labor and materials for the construction of a portable toilet in the amount of PHP770,000.00, additional labor for various projects in the amount of PHP1,671,300.00 and additional fuel for various projects in the amount of PHP321,957.36.

SECTION. 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160.


