The amount of ₱2,767,579.44 from various continuing appropriations of the 20% Development Fund (DF) is hereby reverted to the unappropriated balance of the Development Fund (DF) to add up to the existing balance of ₱1,496,018.66 which totaled to ₱4,263,598.10 and to appropriate the amount of ₱2,612,349.51 out of the said existing unappropriated balance for the Improvement of Maninihon-Cansumalig-San Isidro Farm to Market Road.


Section 2. This ordinance shall take effect upon the approval of the Local Chief Executive.


