RESOLUTION NO. 737

“WHEREAS, the gift of life is the greatest miracle God has given to mankind.

“WHEREAS, mankind should preserve life to the best way he can to please God.

“WHEREAS, one way to preserve life is to have a family whose members are God fearing, law abiding, loving and respectful with one another, especially the old ones.”

“WHEREAS, Bayawanons should realize that life preservation for all human beings has its own limitations and one way to live long in this world, is by taking care of oneself as well as other members of the family especially the old ones.

“WHEREAS, it is the responsibility of the family members to take good care of everybody especially the old ones, to show our gratitude to God, knowing that life is so precious and by all means it has to be preserved with dignity up to the last breath of the individual.

“WHEREFORE, on motion of Honorable Ernesto T. Tijing, duly seconded by Honorable Sharlou F. Jamin, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 58

AN ORDINANCE GIVING FIFTY THOUSAND PESOS (PHP50,000.00) CASH INCENTIVE TO ALL BONAFIDE BAYAWANONS WHO REACHES THE AGE OF 100 YEARS OLD AS PROVIDED FOR UNDER SECTION 3 OF REPUBLIC ACT NO. 10868, WHICH PROVIDES THAT LOCAL GOVERNMENT UNIT CONCERNED SHALL DETERMINE THE AMOUNT OF CASH INCENTIVE.

Be it ordained by the Sangguniang Panlungsod of Bayawan City the guidelines of this Ordinance.

Section 1. Title

This ordinance shall be called "An ordinance granting Fifty Thousand Pesos (PHP50,000.00) cash incentive to all Bonafide Bayawanons who reaches the age of 100 years old as provided for under Section 3 of Republic Act No. 10868.

Section 2. Committee -in- Charge.

The federation of organizations of Senior Citizen in Bayawan City should create a Committee in Charge in checking the qualifications and authenticity of all documents presented by all applicants who wish to avail of the award. This is called the Senior Citizen Committee on Centenarian award.

Section 3. Guidelines.

The following are the guidelines on the implementation of the awarding of the cash incentive of PHP50,000.00 to any Bonafide Bayawanon.

A. Qualifications.

1. Must be a Filipino Citizen.
2. Must be a resident of Bayawan City for at least ten (10) years before receiving the Centenarian Award of PHP 50,000.00.
3. Must have reached the age of 100 years old in his last birthday.
4. Must be a member of any local Senior Citizen organization.
5. Any bonafide Bayawanon who reaches the age of 100 years old but died before the date of the awarding ceremony is entitled to receive the PHP50,000.00 cash incentive. His/her beneficiary will receive the cash award.

B. Requirements

All applicants are required to submit the following documents to the Senior Citizen Committee on Centenarian Award.

1. Birth Certificate / Married Certificate/ Passport or any documents showing the date of birth or reference to the date of birth of the applicant and present original copy for authentication.
2. Voters ID on the place of residence.
3. Senior Citizen ID.
4. Barangay Certificate stating the applicant is a resident of the Barangay.
5. Picture (3r or 4r) of the applicant with the president of the Senior Citizen Federated President of the City.
6. Indorsed documents shall be signed by the president of the federated senior citizen organization of the City, CSWD head and noted by the Mayor.

C. Mechanics in verification on the authenticity of the documents by the CSWD head.

1. Received and verify authenticity of the documents submitted by the applicants to the head of the Committee on Senior Citizen Centenarium Award.
2. Process the issuance of cash incentive of PHP 50,000.00 to the applicants.
3. Check will be issued to the name of the awardee or qualified representative upon submission of necessary documents.
4. Aside from the cash incentive of PHP50,000.00, the Centenarian Awardee shall receive a Certificate of Recognition.
5. Awarding of the Cash incentive of PHP50,000.00 to the Centenarian winners should be done during their yearly celebration of Senior Citizen Day.

Section 4. Funding.

The initial implementation of this Ordinance shall be sourced from the Executive Department with an initial budget of PHP100,000.00 and subsequently the amount necessary for the implementation of this Ordinance shall be included in the Annual General Fund Budget of the city.

Section 5. Separability Clause.

If for any reason/s, any clause, sentence, provisions of this ordinance shall be held invalid or unconstitutional by any competent court, the same shall not affect the validity and effectivity of the other provisions.

Section 6. Effectivity. This Ordinance shall take effect upon the approval of the Local Chief Executive.


