RESOLUTION NO. 333

“Third and final reading of An Ordinance Granting Christmas Financial Gift in the amount of One Thousand Pesos to Persons with Disabilities (PWDs) in Bayawan City Every December.

“On motion of Honorable Councilor Luis J. Sumalpong and duly seconded by Honorable Councilor Merlita R. Gaudiel, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 11

AN ORDINANCE GRANTING CHRISTMAS FINANCIAL GIFT IN THE AMOUNT OF ONE THOUSAND PESOS TO PERSONS WITH DISABILITIES(PWDS) IN BAYAWAN CITY EVERY DECEMBER

Be it ordained by the Sangguniang Panlungsod of the City of Bayawan, that:

Section 1. Title. This ordinance shall be known as the “CHRISTMAS CASH GIFT FOR PERSONS WITH DISABILITIES (PWDs)”

Section 2. Statement of Principles and Policies

Persons with Disabilities include those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis.

Recognizing their physical infirmities, a principle and policy direction shall be geared towards continuing assistance to them. It shall be the policy of the Local Government Unit to protect the rights of persons with disabilities and promote their welfare to ensure self-reliant and self-development.

Thus, this ordinance aims to promote the well-being of Person with Disabilities in our City by granting them financial gift, in the spirit of Christmas every December to make them happy.

Section 3. Definition of Terms. The following terms shall mean as used only in this Ordinance

- 3.1. *Person with Disabilities* – a person who has a physical or mental impairment that substantially limits one or more major life activity.

3.2 *Disability* - is a condition that makes it more difficult for a *person* to do certain activities or interact with the world around them.

3.3 *Impairment* - A physical or mental defect at the level of a body system or organ

3.4 *Christmas Cash Gift* - this refers to One Thousand Pesos given to a Person with Disabilities every December in the Spirit of Christmas by the Local Government Unit of Bayawan City (LGU- Bayawan City).

Section 4. In the grant of Christmas cash gift to Persons with Disabilities, the following guidelines shall be followed:

4.1. *Who are qualified to avail of the grant:*

4.1 a. Only those Person with Disabilities who are registered and bonafide Bayawanons (Only Bonafide Bayawanons registered as PWD at the City Social Welfare and Development Office)

4.2. *Priorities in the granting of Christmas financial gift:*

Those Person with Disabilities qualified to receive the aforementioned benefit in accordance with Section 4.1 hereof shall be considered priorities under the following circumstances:

4.2a. Those who are blind, deaf, /hard of hearing, lame and unable to walk on their own as identified by the CSWD –

4.2b. Those who are Intellectually disabled as identified by the City Social Welfare Department (CSWD):

4.2c. Those who are actively participating in PWD activities as determined by the record of attendance of their meetings and other sponsored activities, except when their conditions warrant otherwise:

4.2d. Those who are Mentally-illed as identified by the City Social Welfare Department (CSWD), but can reasonably manage the cash gift/or given to his/her guardian:

4.3. *The Screening Committee*

1. SP CHAIR – Committee on Social Services
2. CSWD – PWD Focal Person
3. Federation President

4.4. The President of the Persons with Disabilities Association in every barangay with recommending approval of the Barangay Captain shall submit a list of a qualified bonafide Bayawanon Persons with Disabilities to the City Social Welfare and Development Office, who, after assessment and evaluation of the Screening Committee, shall endorse the same to the City Mayor for approval. The City Mayor shall subsequently endorse the result of the screening with the list of the qualified Persons with Disabilities to the Sangguniang Panlungsod for confirmation through SP resolution.

Section 5. APPROPRIATION - An amount of *One Million Five Hundred Thousand Pesos* or an amount equivalent to the number of PWDs in Bayawan City shall be appropriated yearly for the implementation of this Ordinance which shall be administered by the CSWD of Bayawan City.

Section 6. SEPARABILITY CLAUSE – If for any reason, any portion or provision of this Ordinance is declared unconstitutional or invalid, the other sections or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 7. REPEALING CLAUSE – Any Ordinance or part thereof which are inconsistent with this Ordinance are hereby repealed.


Section 8. EFFECTIVITY – This Ordinance shall take effect upon compliance with the mandatory posting and publication requirement prescribed under Republic Act. No. 7160, otherwise known as the Local Government Code of 1991.


