“RESOLVED, To approved the foregoing request of the Honorable Mayor Rene G. Gaudiel and to enact as it hereby enacts the following ordinance, to wit;

ORDINANCE NO. 43

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP690,000.00 REPRESENTING SAVINGS IN CURRENT APPROPRIATION FOR VARIOUS PERSONAL SERVICES UNDER THE ECONOMIC ENTERPRISE-PUBLIC MARKET OPERATION FOR OTHER PERSONNEL BENEFITS-PRODUCTIVITY ENHANCEMENT INCENTIVES AT PHP30,000.00 EACH NET OF TAX PURSUANT TO DBM BUDGET CIRCULAR NO. 2011-4 DATED DECEMBER 5, 2011.

Be it ordained that:

SECTION 1. The amount of PHP690,000.00 representing savings in current appropriation for various personal services under the Economic Enterprise-Public Market Operation is hereby re-appropriated for other Personnel Benefits - Productivity Enhancement Incentives at PHP30,000.00 each net of tax pursuant to DBM Budget Circular No. 2011-4 dated December 5, 2011.


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


