AN ORDINANCE REVERTING THE AMOUNT OF PHP280,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR THE E-NGAS PROJECT – PURCHASE/ACQUISITION OF IT EQUIPMENT AND SOFTWARE OF THE OFFICE OF THE CITY MAYOR TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR E-NGAS IMPLEMENTATION (MAINTENANCE AND OTHER OPERATING EXPENSES)

Be it ordained that:

SECTION 1 The amount of PHP280,000.00 representing savings in continuing appropriation for the e-NGAS Project – Purchase/Acquisition of IT Equipment and Software of the Office of the City Mayor is hereby reverted to the un-appropriated balance of the General Fund and to re-appropriate the same for e-NGAS Implementation (Maintenance and Other Operating Expenses),.


SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.




