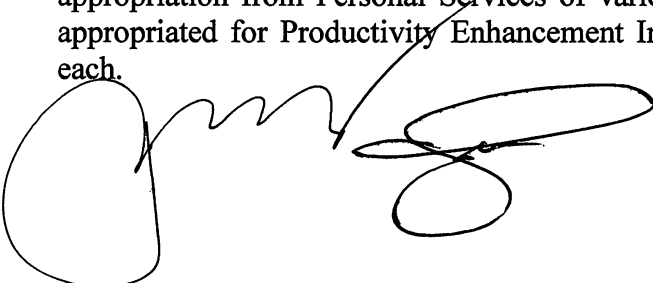
“On motion of Honorable Councilor Renacia and duly seconded by Honorable Councilor Tijing, the Council

APPROPRIATION ORDINANCE NO. 25

Be it ordained that:

SECTION 1. The amount of PHP24,115,000.00 representing savings in current appropriation from Personal Services of various offices under the General Fund is hereby re-appropriated for Productivity Enhancement Incentive (PEI) of LGU Employees at P35,000.00 each.



SECTION 2. The amount of PHP1,120,000.00 out of the Loan Repayment from BAWAD is hereby appropriated for Productivity Enhancement Incentive (PEI) of LGU Employees at PHP35,000.00 each.

SECTION 3. This Ordinance shall take effect after compliance with the provisions of R.A. 7160, the LGC of 1991.

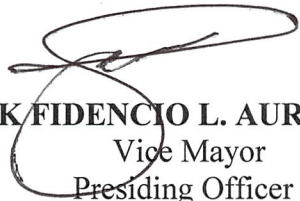

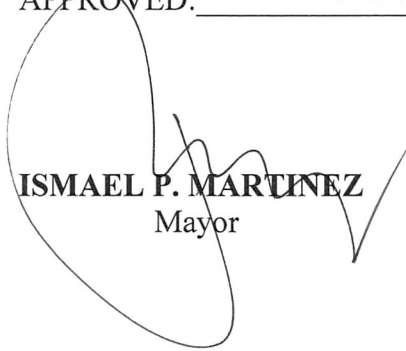
