AN ORDINANCE REVERTING THE AMOUNT OF PHP53,815.79 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION OF THE OFFICE OF THE CITY MAYOR (MOTOR VEHICLES) AND NON-OFFICE EXPENDITURES (ACQUISITION OF HEAVY EQUIPMENT – BULLDOZER) TO THE UNAPPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME FOR THE COMPLETION OF THE PUBLIC COMFORT ROOM AT THE CITY PLAZA UNDER THE OFFICE OF THE CITY ADMINISTRATOR.


