“RESOLVED, to approve the foregoing request of the Honorable City Mayor Rene G. Gaudiel and to enact the following ordinance, to wit:

ORDINANCE NO. 11

AN ORDINANCE REVERTING THE AMOUNT OF PHP2,500,000.00 REPRESENTING SAVINGS IN CONTINUING APPROPRIATION FOR FARM TO MARKET ROAD REHABILITATION TO THE UN-APPROPRIATED BALANCE OF THE GENERAL FUND AND TO RE-APPROPRIATE THE SAME AS SUPPLEMENTAL BUDGET NO. 9 FOR CY 2013 FOR REHABILITATION OF GK VILLAGE MAIN ROAD.

Be it ordained that:

SECTION 1. The amount of PHP2,500,000.00 is hereby reverted to the un-appropriated balance of the General Fund and to re-appropriate the same for rehabilitation of GK Village main road.

SECTION 2. This ordinance shall take effect after compliance with provisions of R.A. 7160, the LGC of 1991.


