RESOLUTION NO. 256

“WHEREAS, time has come that the LGU of Bayawan City has to put up a City Public Library as Bayawan is a growing city;

“WHEREAS, said library is a good source of information/knowledge especially to students, teachers, and to the general public as well;

“WHEREAS, said reading center will serve as a deterrent to journal delinquency, and relaxation place to book loving people;

“NOW, THEREFORE, on motion of Honorable Guillermo A. Diao and duly seconded by Honorable Councilor Raymond, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance, to wit:

ORDINANCE NO. 26

AN ORDINANCE CREATING A CITY PUBLIC LIBRARY AND PROVIDING FUNDS THEREFORE.

Be it ordained:

Section 1. Short title. City Public Library.

Section 2. Administration. The City Public Library shall be under the Office of the City Administrator.

Section 3. Qualification. The City Librarian shall possess the following qualifications:

1. A graduate of at least 4-year Bachelor degree course:
 - a. Preferably major in Library Science or
 - b. Have experience in library works for at least One (1) year or
 - c. Who have taught in public or private school for at least One (1) year.
2. Must possess at least Civil Service Eligibility – 2nd level.
3. Certification of good moral character from his/her barangay.

Section 4. A Salary Grade. The position of City Librarian shall have a salary grade of 12.

Section 5. Appropriation. The City Mayor shall appropriate TWO HUNDRED EIGHTEEN THOUSAND FOUR HUNDRED SIXTY-SIX (Php218,466.00) PESOS for One (1) Librarian, broken down as follows:

Salaries and Wages-Regular Pay	Php 142,044.00
Personal Economic Relief Allowance (PERA)	6,000.00
Additional Compensation	18,000.00
Clothing/Uniform Allowance	4,000.00
Productivity Incentive Bonus	2,000.00
Cash Gift	5,000.00
Year-end Bonus	11,837.00
Life & Retirement Contribution	17,046.00
PAG-IBIG Contribution	1,200.00
Phil-Health Contribution	1,650.00
ECC Contribution	1,200.00
Other Personnel Benefits	8,489.00

and another ONE HUNDRED TWENTY THOUSAND (Php120,000.00) PESOS for books, magazines and other reading materials, and furniture and fixtures, all in Philippine currency, for a total amount of THREE HUNDRED TWENTY-EIGHT THOUSAND THREE HUNDRED ELEVEN (338,466.00) PESOS.

Section 6. Effectivity. This ordinance shall take effect after compliance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991.


