AN ORDINANCE APPROPRIATING THE AMOUNT OF PHP9,180,000.00 OUT OF THE PHP42,042,290.07 REPRESENTING THE UN-APPROPRIATED SURPLUS OF THE CITY FOR CY 2005 OPERATION TO COVER THE ADDITIONAL COMPENSATION FOR REGULAR AND CASUAL EMPLOYEES OF THE CITY AT PHP1,000.00 PER MONTH EFFECTIVE JANUARY 2006 IN LINE WITH DBM-LOCAL BUDGET CIRCULAR NO. 2006-2 DATED MARCH 2, 2006 .

SECTION 1. The amount of PHP9,180,000.00 out of the PHP42,042,290.07 representing the un-appropriated surplus of the City for CY 2005 operation is hereby appropriated to cover the additional compensation for regular and casual employees of the city at PHP1,000.00 per month
