Be it ordained that:

 SECTION 1. The amount of PHP2,042,650.00 out of the un-appropriated surplus of the city for CY 2005 operation is hereby appropriated for the one year rubber technology course funded by the city government.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A.7160, the LGC of 1991.
