ORDINANCE NO. 31

AN ORDINANCE RE-APPROPRIATING THE AMOUNT OF PHP40,000.00 REPRESENTING THE SAVINGS IN CURRENT APPROPRIATION OF THE GENERAL SERVICES OFFICE FOR OTHER MAINTENANCE AND OPERATING EXPENSES UNDER THE GENERAL FUND FOR GASOLINE, OIL AND LUBRICANT OF THE GENERAL SERVICES OFFICE.

SECTION 1. The amount of PHP40,000.00 representing the savings in current appropriation of the General Services Office for Other Maintenance and Operating Expenses under the General Fund is hereby re-appropriated for gasoline, oil and lubricant expenses of the same office.

SECTION 2. This ordinance shall take effect after compliance with the provisions of R. A.7160, the LGC of 1991.
