“Third and final reading of An Ordinance amending the Title and Section 3 (3.1, 3.2, 3.4 & 3.5) of Ordinance Number 04, series of 2016, otherwise known as “An Ordinance Institutionalizing Bayawan Federation of Persons with Disabilities and Providing Monthly Cash Assistance to Every Chapter President thereof.”

“On motion of Honorable Councilor Gaudiel and duly seconded by Honorable Councilor Trias, the Council

“RESOLVED, To enact, as it hereby enacts the following ordinance:

ORDINANCE NO. 7

AN ORDINANCE AMENDING THE TITLE AND SECTION 3 (3.1, 3.2, 3.4 & 3.5) OF ORDINANCE NUMBER 04, SERIES OF 2016, OTHERWISE KNOWN AS “AN ORDINANCE INSTITUTIONALIZING BAYAWAN FEDERATION OF PERSONS WITH DISABILITIES AND PROVIDING MONTHLY CASH ASSISTANCE TO EVERY CHAPTER PRESIDENT THEREOF”

Be it ordained by the Sangguniang Panlungsod of the City of Bayawan in session assembled, that:

Section 1. The Title and Section 3 (3.1, 3.2, 3.4 & 3.5) of Ordinance Number 04, series of 2016, otherwise known as “An Ordinance Institutionalizing the Bayawan Federation of Persons with Disabilities and Providing Monthly Cash Assistance to Every Chapter President Thereof” is hereby amended and read as follows:

“Section 1. Title. This ordinance shall be known as AN ORDINANCE INSTITUTIONALIZING BAYAWAN FEDERATION OF PERSONS WITH DISABILITIES AND PROVIDING MONTHLY FINANCIAL ASSISTANCE TO EVERY CHAPTER PRESIDENTS THEREOF”

“Section 3. Funds

3.1 Amount Allocation : Php 384,000.00 annually

3.2 Purpose of Allocating Funds: the amount in the form of monthly financial assistance for Bayawan Federation of Persons with Disabilities (BFPWD) Chapter Presidents shall be utilized to defray Persons With Disabilities (PWD) related activities as to their functions, duties and responsibilities.

3.3 Source of Funds. As per approved SP Resolution no. 306 dated April 21, 2015 relative to the Bayawan Federation of Persons with Disabilities (BFPWD) Resolution no. 06 series of 2015, the same amount appropriated from the budget allocated to City Social Welfare Development charged to Elderly Persons With Disability Program in which GAA Sec.29 stated that the least one percent of all government agency budget shall be allocated to elderly and Persons With Disabilities (PWD) related programs, projects and activities.

3.4 Amount Allocation Category : Urban & Rural Barangay Chapter Presidents

32 Chapter President x 1,000.00 x 12 months: 384,000.00 annually

Section 2. Repealing Clause: All ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to the provisions of the ordinance are hereby repealed, amended or modified accordingly.

Section 3. Effectivity. This Ordinance shall take effect January 1, 2018




