ORDINANCE NO. 32

AN ORDINANCE REAPPROPRIATING THE AMOUNT OF PHP3,835,000.00 REPRESENTING SAVINGS FROM THE PHP10,000,000.00 LGU EQUITY TO FOREIGN ASSISTED PROJECT UNDER THE 20% ECONOMIC DEVELOPMENT FUND FOR CY 2006 AS ADDITIONAL BUDGET FOR THE BAYAWAN WATERSHED MANAGEMENT AND REHABILITATION PROJECT (TUBA-TUBA PROPAGATION), LGU EQUITY TO REFORESTATION.

Be it ordained that:

SECTION 1. The amount PHP3,835,000.00 representing savings from the PHP10,000,000.00 LGU equity to foreign Assisted Project under the 20% Economic Development Fund for CY 2006 is hereby reappropriated as additional budget for the Bayawan Watershed Management and Rehabilitation Project (Tuba-tuba Propagation), LGU Equity to Reforestation.
